1 AN ACT relating to fiscal matters providing funding for disaster recovery and 2 relief, making an appropriation therefor, and declaring an emergency.

- 3 Be it enacted by the General Assembly of the Commonwealth of Kentucky:
- Section 1. There is hereby appropriated General Fund moneys in the amount of

- 10 (a) \$30,000,000 to the Kentucky Department of Education for school districts

- 1. Providing the necessary wrap-around services for school children and their
- families in recovering from the impact of the storms and tornadoes, including after-school
- services and activities held at the school facilities or elsewhere in the community, mental
- 15 health counseling services, and outside-of-school tutoring and other services to advance
- 16 the scholastic progress of students;
- 17 2. Assisting school districts in addressing the additional transportation costs to
- 18 provide transportation to students that are displaced from their district or county; and
- 19 3. Transferring a portion to the School Facilities Construction Commission to
- 20 offer funding for the construction and repairs of school building facilities that have been
- 21 destroyed or severely damaged by the storms and tornadoes. If a school district receives
- 22 insurance funds for the facility, the school district shall reimburse the fund an amount
- equal to the amount received from insurance proceeds; and
- 24 (b) \$15,000,000 to the Department of Military Affairs, Division of Emergency
- 25 Management, to be used for procuring temporary FEMA-eligible housing units.
- Section 3. Notwithstanding KRS 48.630 or any other statute to the contrary,
- except as provided for in Section 2 of this Act, the funds appropriated or deposited into

4	→SECTION 4. A NEW SECTION OF KRS CHAPTER 39A IS CREATED TO
5	READ AS FOLLOWS:
6	(1) The West Kentucky State Aid Funding for Emergencies (SAFE) fund is
7	established and shall be:
8	(a) Administered by the Department of Military Affairs, Division of Emergency
9	Management, in accordance with section;
10	(b) A separate fund to provide financial assistance for those impacted by the
11	December 2021 storms and tornadoes that occurred in the west Kentucky
12	region; and
13	(c) Used to provide financial support to the west Kentucky region to recover
14	from the devastation caused by the storms and tornadoes.
15	(2) The Department of Military affairs or the Division of Emergency Management
16	shall not publicly advertise or solicit contributions from the general public that
17	could potentially impact fundraising efforts of not-for-profit disaster relief
18	agencies.
19	(3) The fund may receive state appropriations, gifts, grants, federal funds, and any
20	other funds both public and private.
21	(4) Moneys in the fund as of June 30, 2022, and June 30, 2023, shall not lapse and
22	shall carry forward until June 30, 2024.
23	(5) Any interest earnings of the fund shall become a part of the fund and shall not
24	<u>lapse.</u>
25	(6) (a) Eligibility to receive financial support from the fund shall be limited to a:
26	1. City, county, urban-county government, consolidated local
27	government, unified local government, or charter county government;

1		2. Nonprofit or public utility service provider;
2		3. State agency; or
3		4. School district;
4		that has disaster-related needs as a result of the devastation experienced
5		from the December 2021 storms and tornadoes.
6	<u>(b)</u>	An eligible recipient may receive tornadoes for expenses to provide disaster
7		and recovery relief if the recipient:
8		1. Is located in the areas named in a Presidential Declaration of
9		Emergency relating to the storms and tornadoes that occurred in
10		December 2021; and
11		2. Has disaster-related needs in response to the storms and tornadoes
12		that occurred in December 2021.
13	<u>(c)</u>	Eligible expenses shall be those used to support disaster and recovery relief,
14		including but not limited to:
15		1. Replacement or renovation of public buildings damaged by the storms
16		and tornadoes;
17		2. Reimbursement for services, personnel, and equipment provided
18		during the response and recovery to communities impacted by the
19		storms and tornadoes;
20		3 Funding to cities, counties, and publicly owned utilities for the costs of
21		replacement or repair of publicly owned buildings and their contents
22		due to the damage from the storms and tornadoes;
23		4. Assistance to cities and counties for expenses related to planning
24		efforts for rebuilding and recovering from the damage;
25		5. Assistance to utilities serving Graves and Hopkins Counties for
26		resilient response and future risk reduction through the burying of
27		utility wires that will enhance power reliability, reduce power loss, and

1			lessen risk to human life; and
2			6. Assistance to support disaster recovery and relief needs of local school
3			districts, including but not limited to:
4			a. Financial support for school districts that will experience a
5			default in bond payments; and
6			b. Financial support to assist school districts with building needs.
7	<u>(7)</u>	Eac	h recipient of moneys from the fund, including any agency of Kentucky state
8		gove	ernment, shall:
9		<u>(a)</u>	Timely apply for federal emergency disaster grant assistance, other
10			financial disaster assistance, and insurance proceeds; and
11		<u>(b)</u>	Adhere to the terms of the fund regarding reimbursement to the
12			Commonwealth if funds from other sources are subsequently received after
13			the receipt of financial assistance from the state.
14	<u>(8)</u>	(a)	Moneys in the fund may be used for the advancement of moneys to cities
15			and counties experiencing strained fiscal liquidity while awaiting
16			reimbursement from federal emergency management assistance or
17			insurance claims.
18		<u>(b)</u>	Reimbursement of the advancement under paragraph (a) of this subsection
19			shall:
20			1. Be determined by the Department for Local Government's state-local
21			finance officer; and
22			2. Include a quarterly accounting of the advancement released and the
23			outstanding balance through June 30, 2024.
24	<u>(9)</u>	(a)	If a recipient of moneys from the fund subsequently receives moneys from
25			any other source, the recipient shall reimburse the Commonwealth for the
26			amount of the moneys received from the fund.
27		<u>(b)</u>	All moneys reimbursed to the Commonwealth under paragraph (a) of this

1	subsection shall be deposited in the general fund within thirty (30) days.
2	(10) The Division of Emergency Management shall promulgate administrative
3	regulations to carry out this section.
4	(11) The following reports shall be submitted to the Interim Joint Committee on
5	Appropriations and Revenue by the tenth day of each month, beginning February
6	10, 2022, and ending July 10, 2024:
7	(a) A report from the Office of State Budget Director that includes:
8	1. The name of each recipient of moneys from the fund;
9	2. The dollar amount of moneys received; and
10	3. A description of how the moneys were used; and
11	(b) A report from the Department of Education that includes:
12	1. The name of each school district receiving moneys from the fund;
13	2. The dollar amount of moneys received; and
14	3. A description of how the moneys were used.
15	→ Section 5. Whereas support and relief efforts are imperative for the
16	Commonwealth to recover from the considerable damage caused by deadly storms and
17	tornadoes, an emergency is declared to exist, and this Act takes effect upon its passage
18	and approval by the Governor or upon its otherwise becoming a law.
